

General comments

Fazenda Gameleira I, II and III are contiguous properties located on the border of the Indigenous Territory Urubu Branco. The properties Fazenda Gameleira I and Gameleira II have the CAR declaration validated by the Environment Agency of Mato Grosso (SEMA - MT). The property Fazenda Gameleira III has a CAR declaration still in analysis (1). Also in Confresa (MT), the Poltronieri family owns Fazenda Luta. Farmers and indigenous people neighbouring Fazenda Luta, the largest producer of genetically modified soybeans in the region, have been suffering the effects of pesticide spraying applied on the property since 2013, when the Poltronieri family started the business. In 2015, three small producers registered a report in the Civil Police of Confresa against Fazenda Luta for abandonment of toxic substances harmful to the environment (2). In addition to soybeans, Fazenda Luta produces rice and corn (3). In Confresa (MT), Dilmas Poltronieri has an authorization for deforestation and an authorization for clearance of 886 hectares of native vegetation in Fazenda Gameleira I (valid until December 2023) issued by SEMA - MT. The same area had another authorization for clearance of 890 hectares of native vegetation (later changed to 886 ha) that was valid until July 2020. Poltroniere is being investigated for frauds linked to the registration of the CAR of Fazenda Gameleira I as a result of the Polygonum operation, an investigation conducted by the Civil Police and state Public Prosecutor Office of Mato Grosso, which discovered a scheme to enter false information of farm boundaries into SEMA systems (4). The properties Fazenda Gameleira I and Gameleira II have Frenova Agropecuária (CNPJ: 03.143.914/0001-08) as its registered owner in SIGEF and are registered as Fazenda Luta e Gabriela and Fazenda Luta e São Gonçalo. The state tax office of Mato Grosso lists Frenova as a 'closed' company. One of the owners of Frenova, José Carlos Pires Carneiro, is linked to companies responsible for "colonization" processes in the central-western part of the country during the Brazilian military dictatorship (1964-1985), being also one of the owners of Tapiraguaia Agrícola e Pecuária (5, 6). Frenova is one of the companies that contested the demarcation of Indigenous Territory Urubu Branco (7). In the 1980s, indigenous organisations accused José Carlos Pires Carneiro for illegal activities in the area where the Indigenous Territory Urubu Branco currently is (Tupinaré people) (8).
