Cláudia and Hiladio are also the daughter and son-in-law of Gregório Marin Preciado and Vicencia Talan Marin, who was linked to Senator José Serra (involved in Lava Jato) through properties and companies, as well as family relationships (Vicencia is a cousin of José Serra) (1).</p>
